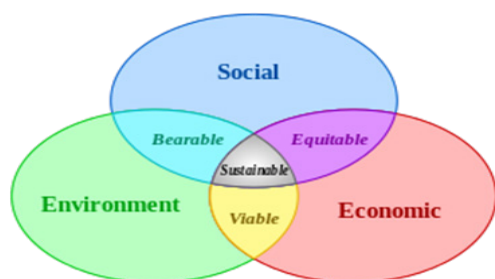
Economic Status
